GUIDELINES FOR INDIVIDUAL GRANT APPLICATIONS

Here are a few simple rules and requirements.

- Applicants must be under 18 years of age at 01/01/2010
- Grants for equipment, coaching and events must be applied for in advance. Grants cannot be awarded retrospectively.
- Golf Professionals must meet the requirements, as specified in the Application Form.
- Competition Expenses –Travel and accommodation expenses should be listed for National and Regional Championships only. See entry forms and info on www.englishwomensgolf.org.
- Equipment – Should only be listed if it is essential and you need financial help. We may be able only to make a contribution.
- Girls applying for grant aid should try to play in as many Surrey Girls events as family commitments allow.

- Following the assessment meeting all applicants will be notified individually of any Grant awarded, which will be payable on receipt of the relevant invoices/receipts.
